Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:
	<ul> <li>Social Security number and account balances</li> <li>payment history and transaction history</li> <li>credit card history and wire transfer information</li> </ul>
	When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Arcadia Credit Union

	State laws and individual companies may give you additional rights to limit sharing.	
Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.	
	Arcadia Credit Union does not have any affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can b financial and nonfinancial companies.	
	Arcadia Credit Union does not share with non-affiliates so they ca market to you.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.	
	<ul> <li>Our joint marketing partners include insurance companies.</li> </ul>
